5. Matter arising from minutes

Cllr Nicholas has investigated without success as to why some properties maybe voting under one parish but pay council tax to a different parish.

Action - Cllr Whybrow to liaise with Cllr Nicholas and MSDC to investigate this issue further

6. Better Broadband update – Ben Skinner

Jonathan Chown has advised Ben Skinner that BT are still working within the time frame that they had planned and that relevant investigation work has been carried out. BT are currently in Phase 3 where they are going into planning and investigating what resources they will be needing for the better broadband project. Phase 4 will be the work being carried out, BT will contact Battisford Parish Council once it has been established exactly what they need to do.

24. (b/f) Tesco Grant

Cllr Cleaver explains that a funding application for the Tesco '*Bags of Help*' scheme was submitted by Battisford Play Area Group Committee in order for an exciting new play area to be installed within the parish of Battisford. Cllr Cleaver advises that Battisford play area has been awarded a grant of either £8,000, £10,000 or £12,000 depending on how many in store customer votes are received. Voting will start on 27th February 2016 in local Tesco stores for one week only until 6th March 2016. Cllr Whybrow also advises Battisford Parish Council that £1,500 has been awarded from his budget for Battisford play area.

19. (b/f) Play area gate

An email has been received from one of the volunteers in the village that opens and shuts the gate at Battisford village green to advise that the gate has been levered off its hinges. Cllr Knock has offered to re-weld the gate in order for it to be open and shut again by volunteers.

PARISH REPORT FEBRUARY 2016 BOSMERE DIVISION County Councillor Julia Truelove

BUDGET PROPOSALS

SUFFOLK C.C.S Cabinet met on Tuesday 26th January. Amongst agenda items presented were the revenue Budget 2016-2017 and the capital program for 2016-19. The level of savings being targeted over the next two years totals £73 million. Major issues which have be addressed include the implementation of the single state pension from 2016, the cost of the new demand in adult care services due to the increasing complexity of care needs and the new, 'National Living Wage'

Amongst the savings proposals concerning the public, are the Fire Authority's proposals to close one fire station and remove some functional fire engines at others. This proposal is under consultation as is the closure of the Park and Ride at Copdock.

County Councillor's locality budgets will be reduced from the present annual £12,000 to £10,000 in 2016/17 and £8.000 in 2017/18.

S.C.C.'s Council Tax 2% increase, specifically to fund increased social care costs is proposed, whilst the freeze on general council tax rates has been maintained. The County Council input into the council tax will be £17-50 a year for a Band B property.

The Budget Proposals will be debated at the forthcoming meeting of the full council on Thursday February 11th.

NEW SCHOOLS IN SUFFOLK

The Cabinet agreed the proposals to build seven new primary schools for nearly 1,500 pupils to be opened in 2018 or 2019. Two new schools are proposed for Ipswich, others across the County

including Stowmarket where the Cedars Park school has long been over subscribed. Two new schools are also proposed for children with special needs.

INITIAL FEEDBACK FROM OFSTED INSPECTION RELATING TO LOOKED AFTER CHILDREN AND THOSE LEAVING CARE.

The inspection started on 23rd Nov.2015 and concluded on 17th December. The report will not be published until mid-February. However all areas were inspected to cover what is working well and what needs improving. Rigour is needed and apparently exercised, as some of the children 'in care' have complex needs.

SUFFOLK'S G.C.S.E. AND A LEVEL RESULTS RISE

For the first time in several years, G.C.S.E., A level academic and vocational qualifications are above the national average. Suffolk's results have increased by 2.08% from last year. The rise in the overall league table out of 151 Local Authorities is from 125 up to 106.

1.0 Planning (since 1st December 2015 to date of report)

1.1 Validated -

1.1.1 Bowl Road, Battisford IP14 2LG Reference 0029/16

Erection of a single storey extension to front elevation

1.1.2 Garden House, Church Road, Battisford IP14 2HF Reference 0073/16

Erection of two storey side and single storey front extensions. Erection of double garage and workshop with music room above following demolition of existing garage.

1.2 Decisions -

1.2.1 Bowl Road, Battisford IP14 2LG

Reference 0029/16

Erection of a single storey extension to front elevation Decision - Granted

1.3 Permitted Developments – I'm not aware of any PD's within the parish during the reporting period.

1.4 Other Matters – Wonderlier Farm, Straight Road, Battisford

Discussion and lobbying has been ongoing since my last report. Whilst I've been extremely frustrated with the speed of action I have to acknowledge that the planning and enforcement teams have had to be mindful of minimising the opportunity to challenge their actions particularly with regard to bird welfare issues.

Finally, on 11th February 2016, the landowner was served with an Enforcement Notice, requiring the use of the land and buildings for the keeping of birds to cease, and for all birds to be removed from the site within

12 months of the date the Notice comes in to effect – i.e. as of 14 March 2016, and by 13 March 2017. It is hoped that dispersal of the birds will happen sooner rather than later to mitigate the continuing loss of residential amenity by neighbours.

It is worth noting that enforcement action is still possible and that if the Environmental Health Team received a noise nuisance complaint from neighbours - that would extend to anyone living in the vicinity that feels they are affected by the noise – they would start the investigation process.

2.0 "One-off" Mid Suffolk Locality Award Programme.

I was extremely disappointed at the response to this initiative within the Ringshall Ward. There was up to \pm 5,000 available for award. This was an opportunity for not-for profit groups or organisations to receive direct financial support for their activities – the qualification criteria was very wide and the application process was simple. The only application received from within Battisford parish was for play equipment. A grant of \pm 1,500 will be made.

3.0 Community Infrastructure Levy (CIL).

At a Full Council meeting in January Community Infrastructure Levy (CIL) was adopted. CIL is a framework to collect funds for infrastructure from new developments. From the 11th of April this year MSDC will charge CIL on residential and convenience retail developments in the district, collecting between £50 and £115 in CIL per square metre of floor space depending on the type, size and location of the development.

This will work alongside contributions collected under Section 106 of the Town and County Planning Act and will deliver a clearer and more transparent system for funding infrastructure, providing clear information on costs to both developers and the local authority throughout the development process. MSDC will be responsible for managing the CIL funding.

CIL will give the District Council a predictable funding stream that allows councillors to plan ahead more effectively, while giving developers much more certainty from the start about costs they would expect. As a result of development communities will receive a direct allocation of either 15% or 25% of the CIL funds. Battisford Parish Council will receive allocation at 15% of the CIL for development in the parish.

The proposals for CIL in Mid Suffolk have been through a strict planning process, including consultations, engagement and an examination by an examiner appointed by the Planning Inspectorate who described the evidence informing Mid Suffolk's charging schedule as "robust, proportionate and appropriate".

Developments on Mid Suffolk's Strategic Sites will continue to collect funds via Section 106 payments rather than CIL.

4. You can leave your cap on.

The Suffolk Waste Partnership has launched a campaign to encourage residents to recycle the aluminium screw tops from glass bottles such as wine, spirits and cooking ingredients, along with the glass bottles on which they came.

The 'Leave Your Cap On' campaign aims to increase the recycling of aluminium screw tops and collars by encouraging people to screw the tops back onto the empty glass bottles before taking them to one of the 1500 glass recycling banks located throughout Suffolk.

The 'Leave Your Cap On' campaign highlights the importance of recycling the aluminium closures which, like all aluminium and glass packaging are 100% recyclable; so every screw top and bottle deposited in a glass bank can be transformed into something new, including more bottles, metal packaging, mobile phones and even car parts.

So when you next recycle your empties remember you can 'Leave Your Cap On.'

5. Citizens Advice Mid Suffolk.

Citizens Advice Mid Suffolk is an independent charity, reliant on grants and donations. Mid Suffolk District Council provides an annual grant to the CAB to help them provide their important advice services to meet the needs of the most vulnerable within our communities. Mid Suffolk CAB has provided their free, confidential and impartial advice service to nearly 3,000 clients in the past 12 months.

During the first 9 months of 2015/16 they have helped residents living in the MSDC Ringshall Ward resolve 125 issues by providing them with free help and advice.

7.0 Devolution update

Greg Clarke and Lord Hestletine met with Leaders of Cambridge, Norfolk Peterborough and Suffolk councils in Cambridge on Monday. It is now clear that there is currently limited enthusiasm in central Government for single county deals. Greg Clark made clear his enthusiasm, and that of the Treasury, for substantial devolution of responsibilities to joint authorities operating at scale. As a result of this Norfolk/Suffolk are now working closely with officers and Leaders in Cambridgeshire and Peterborough as well as Government to explore the possibilities a devolution deal on this geography might offer.
